#### Summerside Ward 5 By-Election Summary

Summerside City Council passed a resolution on Monday, April 17, 2023, naming Tim Garrity as Municipal Electoral Officer (MEO) and Paul Alan as Deputy Municipal Electoral Officer (DMEO).

The Summerside By-election period began on Wednesday, September 11, 2024, with the appointment of Eugene Kelly as the Returning Officer and Mary Olscamp as the Election Clerk.

The Returning Office opened in the St Eleanor's Lions Club on Wednesday September 11, 2024, at 9 a.m. to accept candidate registrations. By Nomination Day Friday, September 20, 2024, at 2 p.m., a total of six residents of Summerside came forward and became officially registered candidates, vying to fill the one vacant councilor seat on Summerside City Council. This seat became vacant following the removal of Councillor Barb Gallant, in the wake of her absence from three consecutive council meetings.

The City of Summerside Election By-laws established three advance polling days for the Ward 5 By-Election. The days determined for Advance Voting Days were Saturday September 28<sup>th</sup>, Tuesday, October 1<sup>st</sup>, and Friday October 4<sup>th</sup>. The second advance day scheduled for the sixth day before Election Day, normally a Monday, was moved by Elections PEI to Tuesday, to recognize the National Day for Truth and Reconciliation on Monday September 30<sup>th</sup>.

A total of 24.41% of registered eligible electors from Ward 5, voted over the course of the three advance days. Election day was Monday October 7<sup>th</sup> with a further 17.29% registered eligible voters from Ward 5 going to the polls to cast their ballot.

Outside of the Advance Polls and Ordinary Polling Day, alternative voting methods for residents of Ward 5 were offered. Any eligible elector from Ward 5 that could not make it to an in-person voting day, could apply for a Mail in Ballot. Elections PEI received a total of thirty applications to process. There was a 66.67% return rate of the Mail in Ballot. Ward 5 residents admitted to the Prince County Hospital also had the opportunity to vote in their hospital room on Election Day. Ward 5 is home to one licensed healthcare facility: The Summerset Manor. Residents were given the opportunity to cast their ballot within their facility.


When the Advance Ballot Counting Team counted all the advance ballots, there was a total of 377 accepted ballots with one ballot rejected or spoiled as the voter left the ballot blank with no selection made. Election Day saw 255 ballots cast with no ballots rejected or spoiled.

The counting teams accepted a total of 632 ballots, for all in-person voting at the polls, Mail in Ballots, hospital votes and the long-term care facility. This represented 42.84% of the registered and eligible 1,475 electors in Ward 5.


#### By-Election Recapitulation (Recap)


The Returning Officer is responsible for filling in out and completing the Recap Sheet. It summarizes the number of ballots cast and for which candidate, with the information provided on the Statement of Poll. The counting teams, comprised of a Deputy Returning Officer and another Election Official, are responsible for examining, deciding, and keeping score of the number of votes cast per candidate on a tracking sheet. They enter these records onto the Statement of Poll and deliver the forms to the Returning Officer. Upon review, the Returning Officers transcribes the Statement of Poll to the Recap sheet and delivers it to every registered candidate. The Advance portion of the Recap Sheet is the culmination of the three days of advance voting, mail in ballots, hospital voting and mobile polls (the licensed healthcare facility in Ward 5)


